As you hone your gardening skills, please be cognizant that the beautiful flowers and greenery you plant for all to enjoy do not spill over onto the sidewalk and impede foot traffic.

Territorial Wall Update

In 2012, the WCE Board hired a professional surveyor to survey the wall adjacent to Territorial Road. The survey results showed that for the most part, the brick wall does not sit on home owner property. The Board and Wall Committee have completed extensive research on solutions to this wall and the damage that the trees are causing to the wall and sidewalk.

We regret to inform everyone that it looks like we will need to remove the beautiful maple trees that line our boundary with Territorial Rd. The Board has looked at many options, but the damage to the sidewalk and the brick wall is making it likely that if we don't remove the trees we'll incur expenses beyond our budget.

The current plan is to remove the trees in the fall, and replant as soon as possible with a tree that won't cause further damage. The Board welcomes your input about tree varieties or any other solutions to what has become a very expensive problem.

Willow Creek Amended Bylaws and CC&Rs Passed

Dear Willow Creek Estates Homeowners,

We are pleased to announce that the WCE Homeowners Association Amended Bylaws and CC&Rs were approved by majority vote! They were recorded with the Clackamas County Recorder's Office on March 4, 2013.

The original documents were created in 1991 when WCE was first developed. Oregon laws pertaining to homeowner associations have changed significantly over the past 22 years, providing for more stringent accounting practices and greater protection of homeowner rights. The new documents were prepared in accordance with current Oregon statutes.

The process of amending the original documents began more than five years ago and was a laborious task involving more than 10% of WCE homeowners. We would like to commend and express our appreciation to everyone who worked diligently in this process. We also thank everyone who took the time to vote on the revised documents.

The final HOA vote count came in as follows: 67 Approve; 3 Do Not Approve; 15 did not vote. The Bylaws required approval by 50% (43 lots) and the CC&Rs required approval by 75% (65 lots) or greater.
